and the Order Modifying Child Support and Alimony and Order Establishing Arrearages dated May 31, 1990, and itemized as follows, being alimony and child support obligations, is determined to be non-dischargeable and the Plaintiff shall have judgment against the Defendant for the amounts set forth below, all pursuant to 11 U.S.C. § 523 (a)(5):


- a. A policy of hospitalization and medical insurance for the minor children with a \$500.00 deductible, and one-half of other medical expenses. (Based on Final Judgment)
- b. A policy of life insurance for the benefit of the minor children with a minimum face value of \$200,000.00, with no loans or deduction, and attorney's fees for the enforcement of this provision. (Based on Final Judgment)
- c. Child support for the minor children (3) in the amount of \$455.00 per month (Based on Order Modifying of May, 1990).
- d. Permanent alimony in the amount of \$250.00 per month until movant dies or remarries (Based on Order Modifying of May, 1990).
- e. Child Support and alimony arrearages of \$18,100.00 (\$9,050.00 for child support and \$9,050.00 unpaid alimony), (Based on Order Modifying of May, 1990), to be paid in payments of \$95.00 per month until paid in full, plus Clerk's fee.



- f. Lump Sum Alimony of \$20,000.00 to be paid at \$2,500.00 per year starting in 1985, less credit for one (1) payment paid. (Based on Final Judgment)

Interest on the unpaid lump sum alimony at twelve percent (12%) per annum which is to be paid annually, which presently totals \$18,900.00. (Based on Final Judgment)
