JUDGMENT

This adversary proceeding came on for consideration before the Court, the undersigned United States Bankruptcy Judge presiding, for the entry of a Judgment pursuant to the Court's Order Granting Joint Motion for Approval of Joint Stipulation for Entry of Judgment in Settlement of Adversary Proceeding. The issues having been duly considered and a decision having been duly rendered,

IT IS ORDERED AND ADJUDGED:

1. The debt owed by Defendant, Herlene L. Frazier, to Plaintiff, American Express Centurion Bank, arising from the Defendant's Blue from American Express Card Account number ****-*****-1000 ("Account 1") and American Express Traditional Gold Card Account number ****-*****-5002 ("Account 2") in the amount of \$4,497.17, plus court costs of \$250.00, for a total of \$4,747.17, together with post-judgment interest from the date of

recording of Judgment at the legal rate provided by Federal law, is nondischargeable pursuant to 11 U.S.C. §523(a)(2)(A) and (A)(2)(C) and shall survive and be excepted from any discharge granted to Defendant in her Chapter 7 Bankruptcy Case No. 10-31803-LMK.

2. Defendant may satisfy the Judgment pursuant to the terms and conditions of the Joint Stipulation; and

3. The Clerk shall mark the above-captioned adversary proceeding as CLOSED, subject to the terms and conditions of the Joint Stipulation.
