JUDGMENT

THIS CAUSE came before the Court on June 17, 1993, for final hearing and the parties having represented to the Court that they have stipulated that the principal amount of the debt by John Dvorak a/k/a Frank John Dvorak, plus the accrued interest shall be considered a non-dischargeable debt and further stipulated that this debt will be repaid as follows: \$5,800.00 on or before 5:00 p.m., June 16, 1993. 


