guaranteed by a governmental unit, or made under any program funded in whole or part by a governmental unit or nonprofit institution, or for an obligation to repay funds received as an educational benefit, scholarship or stipend". The benefit therefrom first became due more than seven years (exclusive of any applicable suspension of the repayment period) before the date of the filing of the Petition herein.

1. The debt owed UNITED STUDENT AID FUNDS as described in the complaint filed herein which was properly scheduled in the debtors' petition is hereby discharged in accordance with the terms of the discharge of joint debtors previously entered by this Court on February 6, 1996.
